Funding is subject to availability and is on a cost-share, reimbursement basis. Grants will not cover more than 50% of the total cost of the project. Maximum grant awards for individual projects will not exceed \$10,000.









CBE reserves the right to follow-up with an onsite visit of the project and to use photos and/or descriptions of the project for future programming and promotion.

Photos of project are helpful, particularly before and after photos that show the impact of the work completed. Please send in jpg or png format, not as a pdf.

Grant funds will not be released until all receipts and evidence of completion are received by CBE.

Application Checklist:

-  Projects must be complete prior to application. Projects in construction must be completed by June 1, 2025.
-  Completed application must be received by 5 pm on the last day of the grant round to be eligible.
 - Scanned or mailed copies of application are preferred. If sending a photo of the application pages, they **MUST** be clear and readable.
-  Detailed description of practice and project-separate pages can be attached. No more than one page per description.
-  A detailed budget of costs from start to finish **MUST** be included with the application (use form attached or a separate form may be attached). Please include copies of receipts for the total cost of the project.
-  Define the impact the project will have:
 - On the individual practice
 - On the beef industry in Pennsylvania (if applicable)
 - On the regional beef community (if applicable)
-  Photos of the project should be submitted to show project completion and improvement to operation. At minimum, submit photos of the completed project. Please submit in jpg or png format, not as a pdf.
-  Be sure to answer all questions on the application and sign before submitting.
-  Grants are reimbursement grant programs. Funds will not be released until all receipts and proof of completion are received by CBE.
